Daly Waters Medical Support and Emergency Services

Daly Waters township is located in the Never Never Ward and within the Roper Gulf region.

Council hold bi-annual community consultations with the surrounding properties and business owners within Daly Waters.

The purpose of the community consultations is to represent the views of the local community to the council who in turn advocate on their behalf.

At the Daly Waters Community Consultation meeting held on 9 November 2022 community representatives expressed their concern in regard to the lack of medical support and emergency services and requested Council write to the relevant Ministers and the Member for Barkly.

Daly Waters is approximately two hours travel by road from the nearest medical services at Mataranka to the North and Elliot to the South. With recent development within the Beetaloo, and an increase in the road-based tourism staying at Daly Waters, there may actually be a need for a medical services, particularly during the dry season with a mobile medical service to respond to the need. At times, we estimate that there can be several hundreds of people in the Daly Waters township vicinity particularly during the drier months.

We await your reply and appreciate the opportunity to provide the community the relevant feedback.
